Storage at room temperature or below up to 30 days, including heating up to 70 °C for up to 2 hours, or heating up to 100 °C for up to 15 minutes.

Overall migration analysis:

Samples of the product, or a similar product made from identical plastic material, have been tested for overall migration according to the test conditions specified in (EU) 10/2011, and the article complies with the overall migration limit of 10 mg/dm² or 60 mg/kg.

ABS: OM2 (10 days at 40 °C), Simulant B, D1. Ratio of food contact surface area to volume: 1.49 dm²/248 ml

A risk-based testing approach was chosen, and a material risk assessment was performed. Migration into aqueous foods can be considered negligible.

Specific migration analysis:

This product contains the following substances that are subject to restrictions under Annex I and II of Regulation (EU) No 10/2011 and amendments – on plastic materials and articles intended to come into contact with food:

1,3-Butadiene, FCM substance no.223 – Specific migration limit (SML): 0.01 mg/kg. Test results: ND.

Acrylonitrile, FCM substance no.225 – Specific migration limit (SML): 0.01 mg/kg. Test results: ND.

A risk assessment according to Regulation (EU) No. 10/2011 and EU Regulation (EC) No 1935/2004 was performed on this product.

The product does not release PAAs above the detection limit specified in Regulation (EU) No. 10/2011.

The product complies with the organoleptic requirements applicable to FCM not yet in contact with food.

This product does not contain substances subject to purity criteria.

This product does not contain substances subject to restrictions apart from the Specific Migration Limits.

No dual use additives were used in the manufacture of this product.

There is no functional barrier present in the product.
