Overall migration analysis:

Samples of the product, or a similar product made from identical plastic material, have been tested for overall migration according to the test conditions specified in (EU) 10/2011, and the article complies with the overall migration limit of 10 mg/dm<sup>2</sup> or 60 mg/kg.

Stainless Steel: OM2 (10 days at 40 °C), 0.5% Citric Acid. Ratio of food contact surface area to volume: 5.97 cm<sup>3</sup>/1000 mL

PP: OM3 (2h at 70 °C), Simulant A, B, D2. Ratio of food contact surface area to volume: 0.65 dm<sup>2</sup>/109 ml

Silicone: OM2 (10 days at 40 °C), Simulant B, D2. Ratio of food contact surface area to volume: 3.18 dm<sup>2</sup>/270 mL. A risk-based testing approach was chosen, and a material risk assessment was performed. Migration into aqueous foods can be considered negligible.

Specific migration analysis:

This product does not contain any substances that are restricted under Annex I and II of Regulation (EU) No 10/2011 and

A risk assessment according to Regulation (EU) No. 10/2011 and EU Regulation (EC) No 1935/2004 was performed on this product.

The product does not release PAAs above the detection limit specified in Regulation (EU) No. 10/2011.

The product complies with the organoleptic requirements applicable to FCM not yet in contact with food.

This product does not contain substances subject to purity criteria.

No dual use additives were used in the manufacture of this product.

There is no functional barrier present in the product.
