This product contains the following substances that are subject to restrictions under Annex I and II of Regulation (EU) No 10/2011 and amendments – on plastic materials and articles intended to come into contact with food: 2,2,4,4-tetramethylcyclobutane -1,3-diol, FCM substance no.881– Specific migration limit (SML): 5 mg/kg. Test results: <1.0 mg/kg.
